Riemann at 812 Marcilene, Wichta, Kansas 67218. It is not a corporate publication of the Society for Creative Anachronism, Inc. and does not delineate S.C.A. policies. Restructuring and reorganization of the SCA, inc. initiated by concerns arising from the January Board of Directors meeting has begun. Offered below, for your edification is a summary of the actions taken in the April meeting.

There are three actions that will have a direct affect on individuals. Nationally, a three dollar (\$3.00) nonmember surcharge for age 18 and older went into effect on June 1st. This is only for those activities which have a site fee required. The pay-to-play, ie. mandatory membership, has been rescinded in favor of this pay-AS-you-play method. An individual would have to attend more than 6 site fee events a year before membership would be financially more beneficial.

Membership rates increased as of June 1, 1994. Currently available membership forms do not reflect this change.

New forms should be available soon.

A possible policy requiring additional site waivers, regardless of, and independent of, membership status is being discussed at this time.

In addition to these three items an InterKingdom Advisory Council is to be formed. "This will have 13 members, one representative for each Kingdom. This council is to advise the Board of Directors on matters involving the medieval recreations side of the SCA. A Grand Council to b e comprised of thirty to forty representatives was also created to look into the enirety of the SCA. Exact details have not been finalized, but this is a long term project of probably a couple of years duration.



I hereby authorize any hospital which has provided treatment to the abovenamed minor to surrender physical custody of such minor to the above-named agents upon the completion of treatment.


These authorizations shall remain effective until . 19 unless sooner revoked in writing delivered to said agents.


